James addresses a particular problem involving our speech that is a tremendous insult to God.

> James says speaking against or judging someone is the same as speaking against or judging God's Law (v. 11a)? What point is James making? God's law is the authority, not us. If we cast judgment on someone, we are basically saying we are the Law.

> What does verse 11b say our focus should be on? Obeying/keeping God's law, rather than trying to play the role of the judge.

> For those who try to play the role of the judge, what does James say about that (v. 12a)? There's only one Judge (God).

> What does verse 12b teach about humility? It is not our place to judge, focus on fulfilling your role and let God fulfill His.
